(State by DPA Bill Grimes. Defendant present with counsel, Larry Wilder. Pursuant to the plea agreement filed herein, the defendant withdraws his former plea of not guilty and enters a plea of guilty to Criminal Mischief (A Misd). The court imposes the following sentence: 1 year suspended. The defendant will be on probation for 1 year. The defendant is to report to probation today. The defendant is to continue counseling and is to have no unlawful contact with victims as special terms of probation. The restitution has already been paid. The court waives the fine, assesses the cost at \$165.00. The defendant shall pay probation users fee of \$50 initial, \$50 administrative and \$20 per month.)
