We have completed our review of the public records of the Office of the Indiana Attorney General in response to the above-referenced request. You asked for copies of records that may have been maintained by this Office regarding case 10C02-1208-PL-088. Your specific requests are outlined below and our responses follow:


4. Any other information and procedures that your Office would use to perform such an analysis.
