NOTICE OF APPEAL

Notice is hereby given that Complainant has filed an APPEAL of the finding of No Probable/Reasonable Cause. A Commissioner will be assigned to **review** Complainant's request for reconsideration. The Commissioner will review the work file, including all documents and evidence submitted during the course of the investigation. The Commissioner **will not reinvestigate** the case.

To Complainant: Please submit any additional **new and relevant** information in support of your request for reconsideration to our office within 10 days after receipt of this notice. There can be no extension of this 10-day time limit. Your request for reconsideration will be assigned to a Commissioner at its next monthly Commission meeting. Typically, the Commissioner reviews the reconsideration and renders a final decision at the monthly meeting following the meeting at which the file was assigned.

Following the review, the Commissioner will recommend to the full Commission one of the following:

- Uphold** the finding of No Probable Cause;
- Remand** for further investigation; or
- Reverse** the finding to Probable Cause

The decision made by the full Commission will be **final** and you will receive a Notice informing you of the final decision concerning the complaint and the Request for Reconsideration.
